- Willing to travel and when necessary work overtime to meet project schedules;
- Excellent communication and collaboration skills;
- Strong time management skills; and
- Creative-thinker and confident sharing ideas for continuous improvement.

- Completion of post-secondary toxicology courses or experience with Human Health and Ecological Risk Assessments; and
- Project management experience.
